5 Approved means for paying a fee

For the purposes of subsection 223(2C) of the Act, the means for paying a fee are by:

- (c) cash, cheque or money order; or
- (d) EFTPOS; or
- (e) EFT; or
- (f) direct debit.

Note: The availability of payment methods may vary depending on the means of filing.

The preferred means for paying a fee are by:

- (a) credit card; or
- (b) direct debit.
