Part 1—Preliminary

1 Name

This instrument is the *Olympic Insignia Protection (Approved Forms) Instrument 2026*.

2 Commencement

This instrument commences one month after the day it is signed.

3 Authority

This instrument is made under section 14 of the *Olympic Insignia Protection Act 1987*.

Part 2—Approved Forms

4 Approved form – Application for registration of an olympic design (OD1)

For the purposes of section 10(2)(a) of the Act, the approved form to apply to register an olympic design is the form at Schedule 1.

5 Approved form – Application to extend or reduce the protection period (OD2)

For the purposes of:

- a) section 11(2)(a) of the Act, the approved form to extend the protection period of a registered olympic design; and
- b) section 11(7) of the Act, the approved form to reduce the duration of the protection period of a registered olympic design, and
- c) section 11A(1) of the Act, the approved form to reduce the duration of the protection period of a registered torch and flame design,

is the form at Schedule 2.

6 Approved form – Request to amend entry in the Register of Olympic Designs (OD3)

For the purposes of regulation 6(1) of the *Olympic Insignia Protection Regulations 1993* (Regulations) the approved form to request to amend an entry in the Register of Olympic Designs for the purposes of correcting a clerical error or an obvious mistake is the form at Schedule 3.

7 Approved form – Representations in response to application to register (OD4)

For the purposes of section 10(6) of the Act, the approved form to make representations about an application to register an olympic design is the form at Schedule 4.

8 Approved form – Representations in response to application to extend the protection period (OD5)
