









Privacy Collection Notice

This Privacy Collection Notice describes how IP Australia collects and manages personal information.

Your privacy rights

Your personal information is protected by law, including the *Privacy Act 1988* (Cth) (**Privacy Act**) and the Australian Privacy Principles (**APPs**), which regulate how entities including IP Australia may collect, use, disclose and store personal information.

IP Australia will only collect your personal information where it is reasonably necessary for, or directly related to, the performance of our functions or activities.

What personal information do we collect?

We collect your personal information from you when you apply for compensation for detriment caused by defective administration.

The personal information we collect from you includes your name, address, date of birth, email address, phone number, and any personal information you provide as part of your explanation of how IP Australia's administration was defective and the detriment you suffered.

Why do we collect your personal information?

We collect your personal information to assess your claim for compensation. If you do not provide the personal information required on the form, IP Australia may not be able to process your claim.

How do we use and disclose your personal information?

We will use and disclose your personal information to assess your claims. We may also contact other Australian Government entities or Australian Public Service employees that could hold information about your claim to request it and use it in order to assess your claim.

Additionally, we may disclose your personal information to third parties where the disclosure is required or authorised by a court or tribunal order, or under an Australian law. For example, this could happen if IP Australia receives a court order compelling the production of information.

IP Australia is unlikely to disclose your personal information to overseas recipients.
