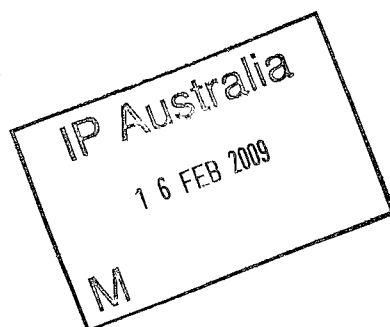


STATUTORY DECLARATION


